



Privacy Policy

Not So Nutty Bars currently collects personal information in one of three ways: (1) through your submission of an online form, (2) through your purchase of Not So Nutty Bars products that appear on the Website, and (3) when you place an order for Not So Nutty Bars products by phone.

Through these submissions you may be required to provide your name, address, phone number, and e-mail address. If you are placing an order for Not So Nutty Bars, you will also be required to submit your credit card and billing information. You may also choose to include your comments or questions you might have on forms.

Not So Nutty Bars also may passively collect information through the use of cookies, web beacons, and other technical means. In addition, our web servers automatically collect information about your computer and the web browser that you are using, including the Internet Protocol ("IP") address of your computer.

Not So Nutty Bars uses the personal information you submit through the Website and by phone to carry out your requests (e.g., to send you information), to process credit card transactions (if you are purchasing products), and for other purposes.

With respect to non-personal information collected passively through technical means, Not So Nutty Bars uses this information for a variety of reasons, including but not limited to, Website administration, troubleshooting, performing statistical analyses of user behavior, and for development purposes. For example, cookies may be used to measure traffic, collect statistical information (such as which pages of the Website are visited most often by users) and to make your visit more pleasant.

Not So Nutty Bars may share personal information you submit through the Website as follows:

With third parties as necessary to provide information or perform services requested by you.

With third party credit card processors in order to process online purchases.

With agents, consultants, and service providers performing analytical and other services on Not So Nutty Bars' behalf.

With other third parties: (a) when required by law or legal process, (b) to investigate illegal activity or unauthorized use of the Website, (c) in connection with the sale of all or

a part of Not So Nutty Bars' stock or assets or those of any Affiliate, or (d) in connection with any bankruptcy or restructuring of Not So Nutty Bars.

Not So Nutty Bars reserves the right to share any aggregated and anonymous information with any third party for any reason. After any personal or aggregate information is provided to third parties, Not So Nutty Bars does not and cannot control their subsequent use or the disclosure of such aggregated and anonymous information and is not responsible for their use.

Not So Nutty Bars uses commercially reasonable efforts to keep your personal information physically secure. Such information is accessible only to authorized personnel as needed to perform operations associated with the performance of this Website and subject to the terms of this Privacy Policy. In addition, when we collect credit card information from you, we use Secure Socket Layer (SSL) encryption. Despite these precautions, however, you must understand that Not So Nutty Bars cannot and does not guarantee absolute security for the information we store or the information you transmit through the Website or to any third party payment processor. Except as stated above, information transmitted to Not So Nutty Bars through electronic means, including without limitation through email and Website forms, are not secure from access by third parties.

This Website is not directed to, or intended for use by, individuals under the age of 18, and Not So Nutty Bars does not knowingly collect or use any personal information from children younger than 13 years old.
